
1.0 **Call To Order/ Pledge of Allegiance** The Special Council meeting of the City of Paisley was held on February 8, 2023 at Paisley City Hall. Mayor Keith Harra called the meeting to order at 7:00 pm. Council Members in attendance were Toni Bailie, Lora Mayea, Travis Garner and Wes Houston. Others in attendance: Melissa Walton, recording minutes.

2.0 **Business**

2.1 **Hiring for Public Works Position** Council received the questionnaire for the interviews and was informed that one applicant had pulled out. **Keith Harra moved to accept his application and hire Eugene Beachler for the Public Works position, Wes Houston 2nd.** Travis Garner is willing to help until Eugene is certified and he does not want paid for it. Eugene is not allowed to do pretty much anything other than repair work (no chemicals) until he is certified. The sewer work will be done under Travis Way. Eugene has one year before he can test for that. Travis Garner believes we should have training/certification on air quality and confined spaces (underground). He has reviewed some of this with Eugene already. Kyler Garner is staying on as a helper for the new person. The only restriction with Eugene is he is not allowed to be around anyone under the age of 18. The only problem Travis sees is having the Community Service people come in with an underage work crew in the summer time. Melissa reported that the interview committee was in agreement to recommend Eugene for the position. **Keith stated there is a motion on the table and called for a vote. Travis Garner abstains, MC.**


3.0 **Adjournment** Meeting adjourned at 7:10 pm.
