



Minutes of May 8, 2023
Special Council Meeting

1. **Call to Order** The Special Council Meeting of the City of Paisley was held on May 8, 2023, at Paisley Community Center. Mayor Keith Harra called the meeting to order at 1:05 p.m. Council members in attendance were Lora Mayea, and Wes Houston. Others in attendance: Eugene Beachler, and Melissa Walton, recording minutes.
2. **Business**
 - 2.1 **Cleaning Bid** Two letters of interest were received. **Lora Mayea moved, Wes Houston 2nd, to hire Edna DeLarm as the custodian for the Community Center, MCU.**
 - 2.2 **New Pump for Well** Lora Mayea moved, Keith Harra 2nd, to move forward with the quote from JW Kerns on a new pump for Well 1, MCU. The pump will be a submersible pump which is more efficient. Keith suggests asking them about other stuff we need done while they are working on the well. Eugene asked about the backup generator; Melissa is going to talk to Dustin about it.
 - 2.3 **Rodeo Club/PYRA** Melissa will talk to Tom Search about the well at the rodeo grounds. Lora asked about selling the rodeo grounds. The City would not have to worry about maintenance costs or a well, and it doesn't produce an income. There is another well at the airport in addition to the well at the seed orchard, but coming from either place to the rodeo grounds would require crossing BLM ground. All of it would cost quite a bit of money and take a lot of time.
 - 2.4 **Picnic Tables** Melissa stated that Council had voted a while ago to pay Eugene for building replacement picnic tables for the broken ones in the park. Eugene had written a quote for \$500 cost per table at that time. Melissa had noticed the other day the table closest to the kitchen has completely failed on one corner. She asked Eugene if he would still be interested and what the cost would be. He wrote another quote for \$500 per table again. **Lora Mayea moved, Keith Harra 2nd, to accept Eugene Beachler's bid for three tables at \$500 apiece to replace the tables currently in the park with the option to build a fourth if necessary, MCU.**
3. **Public Appearances** Eugene worries about there being a problem entering the property at 1105 Main to read the water meter. He has to go through the gate and quite a ways down the fence. He would like to have the home owner place an alcove or gate at the meter box. Lora asked about the letter for the property owner. The County Enforcement Agent visited the property and spoke with Ken Cooper, the Inspector, about the problems. They concluded that Council approved the setbacks on the property so there is nothing the County can move forward with. Keith plans to send the original letter he talked about concerning the clear vision area.
4. **Executive Session** None.
5. **Adjournment** Meeting adjourned at 1:44 p.m.

Next Meeting: The next meeting will be a Budget Committee Meeting on Monday, May 15th, 2023 at 6:30 pm.




